RULES AND REGULATION (*SYARAT DAN PERATURAN*)

CONTESTANT ELIGIBILITY AND REQUIREMENTS (*KELAYAKAN PESERTA*)

1. Entry fee is RM 10.00 per person.
Yuran penyertaan ialah RM 10.00 seorang
2. Contest will be in mixed sequence (no separation by gender).
Pertandingan dijalankan secara bercampur (tiada sekatan jantina)
3. Contestants must be 13 years or above.
Peserta mesti berumur 13 tahun ke atas
4. Professional Singers are not allowed to participate in this contest.
Penyanyi profesional tidak dibenarkan mengambil bahagian.
5. There is no constraint or restriction on the language(s) of song (s) presented; with ABSOLUTELY NO profanity, reference to racial slurs, slander of females and vulgar or explicit sexual lyrics.
Tiada sekatan atau larangan jenis dan bahasa lagu pilihan peserta, TETAPI TIDAK DIBENARKAN SAMA SEKALI lagu yang mempunyai lirik yang berunsur perkauman, menghina jantina, ganas dan seksual
6. Contestants must be Persons with Disabilities (PWDs).
Peserta mesti Orang Kurang Upaya (OKU)
7. CD(s) have to be prepared & brought to the venue by the participants.
CD muzik hendak disediakan dan dibawa ke tempat pertandingan oleh peserta sendiri)

PERFORMANCE (*PERSEMBAHAN*)

8. Contestants may not utilize live props, back-up singers' dancers or animals. Non-human props such as costumes and other accessories are permitted; except for the using of fire. *Peserta tidak dibenarkan menggunakan prop hidup, penari latar atau binatang. Prop bukan-manusia seperti kostum dan aksesori dibenarkan, kecuali penggunaan api*
9. Contestants should not wearing items bearing logos, names, images or messages which can cause misleading of the competition. E.g. : the logo of party politics.
Peserta tidak dibenarkan memakai item yang mempunyai logo, nama, imej dan mesej yang boleh mengelirukan tujuan pertandingan. Contoh : logo parti politik
10. Contestants may accompany themselves with musical instrument.

11. Contestants may sing the same song as another contestant.

12. Contestants who during their performance, use any obscene, offensive, sexual or otherwise inappropriate behaviour or gestures, including without limitation those referencing or depicting violence, nudity or explicit activity; or which are not in the spirit of the contest will be disqualified from the competition.

13. Judging will be based on

<i>Timing</i> (Aturan masa)	– 10%
<i>Presentation</i> (Persembahan)	– 15%
<i>Diction</i> (Sebutan)	– 25%
<i>Expression</i> (Ekspresi)	– 20%
